361 Grant by Henry son of Geoffrey of Parwich to Geoffrey (or Godfrey) son of William of Chaddesden of a bovate in Hognaston at an annual rental of 4d., saving forinsec service (c. 1240).

428 (Agreement between Henry of Kniveton and his step-mother Elizabeth, mentions Lea Hall and Parwich only incidentally)

444 Notification by Elizabeth, widow of Matthew II of Kniveton, that she has received in Underwood the equivalent of the dower she claimed in Parwich from Henry of Kniveton, who was vouched to warranty by Jordan de Sotton' and Avice his wife, and also that she received her assignment of dower from William son of Matthew II of Kniveton in Ashbourne. She has accordingly abandoned her legal action against all the above (1 February 1287).

455 Grant in fee by Henry of Kniveton to Thomas of Parwich of all his meadow in the fee of Bradley and Sturston called le Tinkeremedue, ... ... (20 August 1293)

456 Grant in fee by Henry of Kniveton kt. to Thomas of Parwich of a garden by Henry's mill of Sturston, ... ... (30 December 1292).

## Saltman's Footnotes:

- In 1269 he (Adam Savage) was sued for dower by Margery widow of William of Parwich and by Mary widow of Peter of Parwich.
- 2. In Domesday, Parwich belonged to the king and is therefore classed as 'ancient demesne'. On the royal estates the king's farm was often paid in refined or 'blanched' money.
- 3. In the Derbyshire Eyre of 1269 Robert (de Bentley) claimed 3½ acres in Parwich from Matthew II of Kniveton. He denied having granted the land to Matthew and his heirs by charter and was sent to gaol when this plea proved to be false.
- 4. (Hullisdale) A field-name in Parwich.
- (Pikedeston) Unidentified location. 5.
- (Punfredo) Presumably a personal or place name, probably the former (location unknown). 6.

## "This Place: a Photo Essay" A presentation by Kate Bellis 1st December 2005

The evening was well attended. Kate is a Wirksworth based photographer, with a particular interest in documenting the disappearing and threatened aspects of rural life (see www.katebellis.com). Kate's first work of this type was of local fishermen on a trawler out of Sidmouth when she was 16. This got her hooked on using her camera to tell stories. She studied photography at Nottingham, and after her degree travelled in China and Tibet. Settling in the Peak District, first at Abney and then at Bolehill, Kate realised that in upland Derbyshire for many life was changing as much as in remote Tibet, and what was being lost needed recording just as much.

The first half of the evening was the story of hill farming, quarrying and community life. Kate's house in Bolehill looks across towards Middle Peak Quarry, which has been in one family for five generations. Indeed before that the Taylor family were lead miners. Kate's photographs and the associated stories evoked the feelings of her subjects: "This is a place I want my children to grow up in", "Farming's about had it. Mining and quarrying don't lead workings. On one occasion they found a pair of boots, that on closer inspection were found to be still attached to the feet of a seventeenth century miner. His bones were buried, but his gear can still be seen in the Mining Museum at Matlock. Despite the improvements in technology, quarrying, like mining, can still be a risky job. Now is a time of change for hill farming, a way of life that is on the edge of financial viability. One particularly poignant set of photographs related to the dismantling and sale of Moor Cottage Farm at Bolehill. An uncle and his nephew, Peter, had worked the farm together, but when the uncle died, Peter had to sell up. One of the hardest things Peter found was selling the stock, especially his favourite, called Blue Cow. While she was photographing the sale, Kate's partner firmly instructed her not to bid on Blue Cow, but some how she could not help herself. But the auctioneer kept ignoring her bids, in the end she had to shout 'hoy' at the top of her voice, which so shocked everyone, that it killed the bidding. Kate, uncontested, became the proud owner of an unplanned cow. As Peter said, "Nothing can stay the way it is for ever, everything changes".

The second part of the evening was on a recent project looking at the hill farmers of Northumberland; the show for this is currently on tour. "Hill farming: you couldn't do it if you didn't love it." "You're only there for a blink, but its such a privilege ... ... the land-scape has been farmed for thousands of years". Several members had seen her Peak District exhibitions, and Mike and Gill Radcliffe saw the Northumberland work at a Cork Street gallery in London. Kate's next project is with Bedouin women in the Sinai desert.
